agree to the following:

Article 1

The model will pose for the photographer, and the photographer will take pictures of the model on

Reference is made to Article 2 of this agreement to elaborate on these posing categories.

The agreed payment method for the model, photographer and makeup artist/stylist is TFP (Time For Pictures). The minimum number of agreed digital photos for the model and makeup artist is _____ [enter number]

Reference is made to Article 3 of this agreement to elaborate on the TFP payment method.

Article 2

The posing category referred to in Article 1 means the following:

Portrait/Fashion

This includes photos in which the model is fully dressed, not including lingerie and swimwear. The nipples and/or pubic area are not visibly uncovered in the photo.

Lingerie/Swimwear

This includes photos in which the model is entirely depicted in swimwear or lingerie. The nipples and/or pubic area are not visibly uncovered on the photo.

Topless

This includes photos depicting the model, with the nipples fully or partially visible in the photo, while the pubic area is not visible on the photo.

Aesthetic nudes

This includes photos depicting the model, with the nipples fully or partially visible in the photo, while the pubic area is fully or partially visible in the photo.

Nude

This includes photos depicting the model in whole or in part undressed. All body parts can be visually shown in the photo.

Article 3

The payment method referred to in Article 1 means the following:

The model will receive fully edited and ready-to-use digital photos within two months. The form of delivery is indicated at the bottom of this agreement. The photos will be delivered in a resolution of at least 800x600, printable and in JPG file format. The photographer retains the edited and unedited photos. All parties to this agreement may use and reproduce the photos on their website(s), in their portfolio(s) and for their own promotional purposes. Any other commercial use, such as sale of the photos or transfer of rights to third parties, by one of the parties is only permitted after prior written permission of the other parties. The copyright of the photos rests with the photographer. The portrait right of the photos rests with the model.

Article 4

The selection of the photos to be delivered is the sole responsibility of the photographer based on his quality, style and suitability criteria. The photographer is not obliged to provide access to photos that have not been delivered.

Article 5

With regard to photos that are intended or made unintentionally and fall into a posing category that is not agreed in Article 1 of this Agreement, it is expressly provided that all forms of publication of these photos are prohibited.

Article 6

The payment method agreed in Article 1 is due once this contract has been signed and the photo shoot has been successfully completed.

Article 7

It is expressly forbidden to use (parts of) the photos or to have them used for the production of edits that detract from the original subject. It is also expressly prohibited to use (parts of) photos in a context where the model and/or the photographer appear negatively.

Article 8

When the photographer credits the model, he will use the model's name as stated above in this contract.

If the model publishes the photos on a public portfolio, a website for models, a profile site or a similar medium, the model will credit the photographer as 'Jos Laarhoven Photography'.

Article 9

The photographer will not provide third parties with any information that may infringe on the model's privacy, including personal data, unless the model has given prior permission or when the photographer is legally obliged to do so.

Article 10

The model has shown valid identification to the photographer.

Article 11

The conditions in this contract are valid in all countries of the world. Dutch law applies to this agreement.
